1. Based on the performance in the Computer Based examination held from 26.08.2015 to 30.08.2015 & 01.09.2015 to 04.09.2015 and 16.09.2015, the candidates with the roll numbers listed in the **Annexure-'A'** have been found qualified provisionally for candidature & document verification (D.V.). The listed Roll Numbers are in ascending order & not as per merit. The dates for candidature/document verification are also given in **Annexure-'A'** for various categories of **Sr.Section Engineer**, **Junior Engineer and DMS**.

In addition to the above, candidates listed in **Annexure – 'B'** for various categories of Sr.Section Engineer, Junior Engineer and DMS are also called provisionally for document and candidature verification (**AS ADDITIONAL CANDIDATES**). The dates for candidature/document verification of additional candidates are also given in **Annexure-'B'**. You may please note that being called for document verification, does not, in any way, entitle you for empanelment for job or recruitment in Railways unless and until the offer of appointment is given.

It may be noted that allotment of post will be finalized after document verification for all the posts.

The candidates listed herein are being called on provisional basis. Actual candidature will be decided when they are found suitable after due verification of their candidature and all their original certificates of education, age, caste, etc. and also the original call letters, photographs and signatures, merit position and vacancy position.

Those who had qualified in both the categories i.e for Sr.Section Engineer and Junior Engineer can attend according to their choice for verification on any one of the dates allotted to them. The verification for both the post will be conducted on the same date.

Call letters indicating exact Date, Time & Venue etc for the document verification will be uploaded on our website www.rrbbilaspur.gov.in and SMS as well as email will be sent to successful candidates in their respective mobile numbers and email-ids as mentioned in their application form. The link for downloading the call letter will be made available from 16.02.2016.

It may be noted that calling of candidates for candidature and document verification is subject to the following conditions/instructions. Candidates are advised to read all the instructions/conditions thoroughly, along with the instructions indicated on the call letter etc.

2. You have to bring for verification all your original certificates with two sets of Photostat copies duly attested/self-attested in respect of –

Date: 12.02.2016

- a) Date of Birth proof and matriculation (SSLC/ Matric / 10th certificate)
- b) Pre-degree/10+2/Higher Secondary/ Inter (Where applicable)
- c) Educational qualification proof as mentioned in the employment notification for the above said post(s)(all mark sheets, Diploma/Degree certificate Issued by University/AICTE only)
- d) Community (SC/ST/OBC) proof in the prescribed format (Annexure-3/Annexure-4 of CEN No. 01/2015) issued by competent authority with proper seal and designation of the issuing authority. Please note that OBC candidates have to submit latest community certificates with non-creamy layer certification which is not more than one year old as on the date of verification.
- e) "Minority Community Declaration" affidavit format as per Annexure-8 of CEN No. 01/2015 on non-judicial stamp paper that he/she belongs to the minority community having claimed exam fee exemption. If the affidavit is not produced the document verification the candidature will be rejected as per para 4.01 & 5 B (viii) of CEN No. 01/2015
- f) Income certificate in the prescribed format as per Annexure-7 of CEN No. 01/2015 having claimed exam fee exemption. If the income certificate is not produced during the document verification the candidature will be rejected as per para 4.01 & 5 B (v) of CEN No. 01/2015.
- g) PWD Proof (If applicable) as per Annexure-9 of CEN No. 01/2015.
- h) Ex-serviceman proof (No objection certificate/ Discharge certificate, PPO, Ex-serviceman Book & Identity card etc.)
- i) No objection proof (NOC) from the competent authority, if already employed in Railway or any Government department /public sector undertaking with all services particulars (Date of appointment, present designation etc.). If the NOC is not produced during the document verification, the candidature will be rejected as per para 5(B) (Vii) & 12 of CEN No. 01/2015.
- 3. Candidate must ensure that his/her name, date of birth, father name and other particulars in the original certificates match with entries made in application.
- 4. In case of variation in name /father's name/initial etc. necessary affidavit to be obtained from notary stating the name as filled in application and that appearing in all certificates refers to the same person and submitted at the time of verification.
- 5. You are also required to submit 03 copies of your recent passport size photograph.
- 6. Candidates may be required to stay for more than one day, if necessary.
- 7. **SC/ST candidates can download the free Travel pass ONLINE**. At the time of obtaining **reservation and travelling**, the reservation Clerk or Ticket checking staff will ask for original SC/ST certificates for verification of genuineness of the candidate.
- 8. You may please note that candidature of those candidates who fail to produce original certificates in support of their date of birth/ qualification/community in proper format/ proof of Ex-serviceman/ Proof of PWD/ Minority Declaration/Income certificate/ NOC on the day of counseling/ verification is liable to be forfeited without any further notice.

- 9. The onus of proving the eligibility for the post concerned and the genuineness of the other averments made in the initial application shall rest with the candidates. Their candidature would be purely provisional and would be liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency is noticed at the stage of document verification or later.
- 10. No further time will be allowed for submission of certificates.
- 11. In order to avoid shortfall in the panel, the number of candidates being called for document verification is more than the actual number of vacancies.
- 12. As per para 13 of CEN No. 01/2015 furnishing any false information to the RRB or using unfair means in the examination or deliberate suppression of any information at any stage will render the candidate disqualified and debarred from appearing at any selection or examination for appointment on the Railways or to any other Govt. service and if appointed the service of such candidate is liable to be terminated.
- 13. The final selection of the candidates will be subject to number of vacancies available, performance in the Computer based examination and verification of all original certificates and satisfaction of all prescribed criteria.
- 14. Candidates once empanelled for any of the posts depending on his/her choice/ merit position will not be considered for alternative appointment later if he/she is found medically unfit.
