NTPC SAIL POWER COMPANY PRIVATE LIMITED (NSPCL) is a Premier Joint Venture Company of two Maharatnas- NTPC Limited and SAIL. NSPCL presently has Power Plants at three locations viz. Bhilai, Durgapur & Rourkela. NSPCL supplies power to SAIL Units, Union Territory of Dadra & Nagar Haveli, Union Territory of Daman & Diu and Chhattisgarh State. It has an installed capacity of 814 MW and has immediate expansion plans of 1X250 MW at Rourkela and 2X20 MW at Durgapur.

Applications are invited from eligible, bright, dynamic and result oriented candidates having passed CA/ICWA (final) with two years post qualification experience to work IN THE UNITS OF NSPCL AT BHILAI (CHHATISGARH), DURGAPUR (WEST BENGAL) AND ROURKELA (ODISHA).

#### **EMOLUMENTS:**

Selected candidates will be on probation for a period of 1 (one) year. The emoluments will include Basic Pay, Industrial Dearness allowance, perquisites and allowances and other benefits under social security measures like PF, Gratuity, and Insurances etc. as per applicable rules. In addition, House Rent Allowance will be paid only where company accommodation is not available.

## PLACE OF POSTING:

Incumbent joining the above post is required to work in any unit located at Bhilai (Chhatisgarh), Durgapur (West Bengal) and Rourkela (Odisha) under the control of NSPCL.

#### **SELECTION PROCESS:**

Eligible candidates will have to undergo two hours objective type written examination / test. The list of successful candidates for appearing in interview will be made available at <a href="www.nspcl.co.in">www.nspcl.co.in</a> and communication will be sent to such candidates through email and SMS. All such short listed candidates will have to appear for Personal Interview.

#### **TEST CENTERS:**

Candidates have to choose any two cities according to their priority as Test Centre for written examination/ test from amongst Kolkata, Raipur and Bhubaneswar. The Test Centre will be allotted by NSPCL which may or may not be as per their priority. No change in Test Centre under any circumstance will be considered subsequently. NSPCL reserves the right to cancel or add any centre depending on the response of the candidates for that area / test center.

## **ABOUT WRITTEN TEST:**

The All India Test is tentatively scheduled to be held on **04.10.2015** (Sunday). The written test can be taken in Hindi and English. The test will be in two parts. Part-I will be Knowledge Test and will consist of 70 multiple-choice questions of the relevant discipline(s) as advertised. Part-II will be Aptitude Test and will consist of 50 multiple-choice questions on General Awareness, Quantitative aptitude, English & Reasoning. There is a separate qualifying mark for each part.

1/4th mark will be deducted for each wrong / multiple answered question.

The reserved category candidates are required to submit requisite certificate in the format prescribed by the Government of India and issued by Competent Authority.

### **RESERVATIONS AND RELAXATIONS:**

- Reservations and relaxations for SC / ST / OBC (non-creamy layer) /XSM / PWD (degree of disability 40% or above) candidates will be provided as per Government guidelines. Relaxations will be extended in vacancies identified for SC / ST / OBC (non-creamy layer) / PWD candidates.
- O2 Category once filled in the online application form will not be changed and no benefit of other category will be admissible later on.
- No registration fee will be charged from SC/ST/PWD/Internal candidates.

#### **HEALTH:**
