Heavy Power Equipment Plant, Ramachandrapuram, Hyderabad, located in the State of Telangana, a major manufacturing unit of BHEL, with a workforce of 5065 has currently an opening for one Safety Officer (E1 Grade) to meet the statutory requirement, under the Factories Act 1948 and applicable State Rules.

### Qualifications & Experience:

1. (a) Candidate should possess a recognized full-time degree in any branch of engineering or technology and have a practical experience of working in a factory in supervisory capacity for a period of not less than two years.

Or

A recognized full-time Diploma in any branch of engineering or technology and have a practical experience of working in a factory in supervisory capacity for a period of not less than five years.

Or

A recognized full-time degree in physics or chemistry and have a practical experience of working in a factory in supervisory capacity for a period of not less than three years.

The practical experience for the purpose of this shall necessarily be in manufacturing or maintenance or Safety Department of a factory.

- (b) Candidate should possess a full time degree or diploma or certificate in industrial safety duration of which is not less than one year recognized by State Government under the applicable State rules.
- (c) Candidate should possess adequate knowledge of Telugu.

Upper age limit: 33 years

#### Reservations & Relaxations:

1. Upper age limit is relaxed by 5 years for the candidates who had ordinarily been domiciled in the State of Jammu & Kashmir during the period of 01/01/1980 to 31/12/1989.

2. Age relaxation for Ex-Servicemen will be as per Central Government Rules.

## Selection process:

The selection process shall consist of Written Test and Personal Interviews.

- The written test shall be of multiple choice objective type consisting of 240 questions with duration of two and a half hours. The written test will be held at Hyderabad only.
- Applications received in response to the advertisement shall be screened w.r.t.
  the specifications advertised. All eligible candidates as per job specifications
  shall be invited for the written test. After the written test, names of candidates
  will be arranged in the merit order of the written test marks.
- All candidates, will be grouped together and then arranged in descending order of written test marks and candidates shall be called for interview in the ratio of 1:5.
- Final selection panel shall be prepared by assigning a weightage of 75% for Written Test marks and 25% to Interview marks.

#### **Processing Fee:**

A Non-refundable processing fee of Rs. 250/- will be charged, however, SC/ST/PH and Ex-Servicemen candidates will be exempted from payment of this fee.
