- 1. If competent applications are not received to the 'F' and 'E' grades, the advertised posts will be reorganized and utilized under 'D' and 'C' grades as may be deemed necessary.
- 2. Age limit relaxation up to 5 years will be admissible for SC/ST/OBC/PH/Ex-servicemen and employees of Govt./PSU/ Autonomous Bodies /Universities/CeNS, as per Central Govt. Rules, for all posts notified above.

5. Application Fee:

Women candidates, persons belonging to SC/ST and Persons with Disabilities are exempted from the payment of application fee. Regular employees of CeNS applying for higher position are also exempted.

- 6. The upper age limit in respect of the Scheduled Castes, the Scheduled Tribes, the Exservicemen, Other Backward Classes, Persons with Disabilities shall be relaxed in accordance with the orders issued by the Government of India from time to time in this regard. There shall be no upper age limit in respect of Scientists already working in CeNS on regular basis.
- 7. The selection committee reserves the right to relax the upper age limit for all Scientists' posts in case of highly experienced candidates in specialized scientific areas.
- 8. The crucial date for determining the age limit shall be the closing date for receipt of applications (**30 October 2015**).
- 9. The appointment will attain permanent status after successful completion of prescribed probation period in the relevant grade. Candidates appointed after due process of selection shall be liable to serve anywhere in India and outside.
- 10. A hard copy of the duly filled in application form must be submitted on or before 30 October 2015, along with Synopsis duly filled in, application fee, self-attested copies of all certificates regarding Date of Birth, Educational and Professional qualifications, Experience, Caste/Tribe/OBC/PH/Ex-servicemen (in case claiming reservation or any relaxation) and also,

copies of front-page of each publication, copies of few important publications, a statement of research plans and a statement of technology initiative plans.

- 12. Candidates already in employment in Government Departments, Autonomous bodies / other Govt. funded institutions should apply <u>through proper channel</u>. Such applications should be accompanied by duly authenticated copies of Annual Performance Appraisal Reports (APAR) for the past 5 years and certificates of integrity, Disciplinary and vigilance clearance. And the candidate <u>should produce 'No Objection Certificate' from their employer at the time of interview.</u>
- 13. Those in private employment may submit applications directly.
- 14. Incomplete applications not in the prescribed format / applications received without self attested testimonials of qualifications, experience, caste, etc. and the application fee, if applicable and those received after the due date shall not be considered. No claim for refund of application fee shall be entertained, in any circumstance.
- 15. Separate application may be submitted for each post, if applying for more than one position, with requisite fee for each application.
- 16. Fulfillment of qualifications, experience, etc. shall not entitle any candidate to be called for further process of recruitment / interview. In case of large number of applications received for a post, the selection committee reserves the right to short-list applications by adopting such criteria as may be considered appropriate.
