- a) Selection for 'Proficiency Training' will be done by judging their performance through a walk-in-interview as well as marks obtained in the examination of B.Sc.(Nursing) / Diploma in General Nursing & Midwifery course & Internship certificate (if applicable).
- b) Since the registration of the nurses with State Nursing Council takes some time, the selected trainees will have to deposit their "Certificate of Registration' within three months from the date of their engagement as proficiency trainee nurses, in case they are not in possession of the certificate at the time of interview. Till such time, the engagement of the proficiency trainee nurses will be Provisional.
- c) 'Proficiency Training' will start immediately after the selection of the candidate is completed and orders are issued for engagement of the qualified nurses for "Proficiency Training'.
- d) On completion of training in DSP for 18 months, a 'Certificate of Proficiency' will be issued to the successful candidates based on their satisfactory performance as per M&HS department. The certificate will not be issued in cases of provisional engagement as mentioned at (b) above.
