The Government of India has enacted the National Green Tribunal (NGT) Act, 2010 (19 of 2010) for effective and expeditious disposal of cases relating to environmental protection and conservation of forests and other natural resources including enforcement of any legal right relating to environment and giving relief and compensation for damages to persons and property and for matters connected therewith or incidental thereto. As per Section 3 of the NGT Act, the Central Government has established the National Green Tribunal. It is proposed to fill up the posts of Judicial & Expert Members as per the provisions of the NGT Act, 2010.

2. Applications are invited from eligible Indian citizens for the following post of Members in the National Green Tribunal:-

3. The recruitment of a Member shall be direct recruitment on term basis and will be purely on merit.

4. The Tribunal has five places of sitting i.e. Delhi, Bhopal, Chennai, Kolkata and Pune. A Member, upon selection, may be posted at any one of the above places.

5. Mere eligibility will not entitle any candidate for being selected.

6. The Central Government reserves the right to withdraw advertised posts at any time without assigning any reason and also reserves the right to increase or decrease the vacancies as well as fill or not to fill post and its decision in this regard shall be final.

7. Educational qualifications for appointment to the posts of Judicial and Expert Members in the National Green may be seen under Section 5 of the National Green Tribunal Act, 2010.

The eligibility and terms and conditions of the appointment of the candidate will be governed by the provisions of the NGT Act, 2010 (19 of 2010) and Rules made thereunder including the NGT (Manner of Appointment of Judicial and Expert Members, Salaries, Allowances and other Terms and Conditions of Service of Chairperson and Other Members and Procedure for Inquiry) Rules, 2010 as amended from time to time.
