3. NATURE OF DUTIES:-

May be required to drive either light or heavy vehicle or both and required to perform duties in round-theclock shift also.

4. AGE LIMIT : Minimum 18 years and Maximum 27 years as on 28/03/2016.

The relaxation in upper age limit will be admissible :-

- a) up-to 5 years in case of SC/ST candidates and 3 years for OBC candidates
- b) to Ex-Servicemen upto 33 years (after deducting the period of service from the actual age).
- c) to Departmental Candidates (Central Government Employees) who have rendered not less than 3 years continuous/regular service in the same or allied cadre, as under :
 - a. General 40 years
 - b. OBC 43 years
 - c. SC/ST 45 years
- d) upto 5 years to all persons who had ordinarily been domiciled in Kashmir Division of the State of Jammu and Kashmir during the period from the 1st January 1980 to the 31st December 1989 provided that the relaxation in the upper age limit for appearing at any examination shall be subject to the maximum number of chances permissible under the relevant rules. Certificate should be from the District Magistrate within whose jurisdiction he had ordinarily resided (or) any other authority designated in this behalf by the Government of Jammu & Kashmir to the effect that he had ordinarily been domiciled in the Kashmir Division of the State of Jammu & Kashmir during the period from the 1st day of January 1980 to the 31st day of December 1989.
- e) to children/family members of those who died in the 1984 riots.
- f) in cases of certain other categories such as Children/Family member of those died in 1984 riots, Exservicemen, repatriates, retrenched employees etc. as per extant Government of India orders.

FURTHER RELAXATION IN UPPER AGE LIMIT (if applicable) WILL BE ADMISSIBLE AS PER THE EXTANT GOVT. ORDERS.

NOTE: 1. ONLY DATE OF BIRTH INDICATED IN SSC BOARD CERTIFICATE OR BIRTH CERTIFICATE WILL BE ACCEPTED. NO SUBSEQUENT REQUEST FOR CHANGE SHALL BE ENTERTAINED.

2. The crucial date for determining the age limit shall be the closing date (28/03/2016) for the receipt of the applications from candidates in India.

Eligibility criteria as prescribed in the Advertisement will be determined with reference to the last date for receipt of applications.

Note :-

- 1. Reservation for Ex-servicemen will be applicable as per Government order.
- 2. Ex-Servicemen who have already secured employment in civil side under Central Government in Group C & D posts on regular basis after availing of the benefit of reservation given to exservicemen for their re-employment are NOT ELIGIBLE for claiming benefit of reservation under ex-serviceman category.

7. METHOD OF SELECTION/RECRUITMENT:

Selection will be made on the basis of the performance of the candidate in the objective type written examination with multiple choice answers on General Knowledge, Arithmetic, Motor Vehicle Act, Vehicle Insurance etc. and the driving test for both light and heavy vehicles. Only the candidates qualified in the written test will be called for driving test.

Note : All tests will be held in Mumbai

SC/ST candidates called from outstation for the written test which will be held in Mumbai, will be paid to and fro Travelling Allowance of II Class railway fare by the shortest route, subject to production of tickets and caste certificate. However, Travelling Allowance is not admissible to those SC/ST candidates who are already employed in Central/State Government Services, Central/State Government Corporations, Public Sector Undertakings, Local Government Institutions and Panchayats. Travelling Allowance is also not admissible to Ex-Servicemen (Pensioners) belonging to SC/ST category as per rules and the concession availed from railways, if any, for undertaking journey for attending written examination.

8. HOW TO APPLY: -

- 1. Details of online applications are available in website www.barcrecruit.gov.in
- 2. Persons working under the Central / State Government/Public Sector Undertakings should submit "NO OBJECTION CERTIFICATE" from their employer at the time of written test and driving test.
- 3. Application will be accepted **ONLINE** only.

9. GENERAL CONDITIONS :

- i. In case, the response is more, this Research Centre reserves the right to restrict the number of candidates to be called for the written examination by short-listing the candidates on the basis of longer experience in Driving Light/Heavy Vehicles, Ex-Servicemen (Drivers from Defence Services). The decision of the Research Centre will be final and binding.
- ii. The candidates will be given option to answer the questions in written test either in **HINDI or ENGLISH**.
- iii. The vacancies shown above are provisional and subject to variation. The filling up of vacancies indicated in the advertisement is also subject to the approval of Competent Authority and may not be filled up if decided otherwise in terms of the orders issued by Government from time to time.
- iv. The nature of duties to be performed by the above categories involves working in round-the-clock shift duties, in operational plants and areas.
- v. The eligibility criteria including the period of experience as prescribed in the advertisement will be determined with reference to the last date of receipt of applications (as applicable).
- vi. Candidates may ensure that they fill in the correct information. Candidates who furnish false information will be disqualified for written test. BARC further reserves the right to reject the candidature of any applicant at any stage.

- vii. BARC reserves the right to fill up the post or even to cancel/ restrict/ modify / alter the whole process of recruitment without issuing any further notice or assigning any reason thereof.
- viii. The facility of online application will be open from **14/03/2016 to 28/03/2016**. Candidates are advised to read instructions given on home page of our website by clicking the option "How to apply", before applying.
- ix. The candidates selected against this advertisement may be posted at the discretion of the Competent Authority and subject to the availability of vacancy and liable to serve in any part of India and in any constituent units of the Department of Atomic Energy.
- x. Candidates working under the Central/State Government, Public Sector Undertakings, Autonomous Bodies etc., after the submission of the Online application, should submit the hard copy of the application <u>routed through proper channel</u> to Deputy Establishment Officer, Recruitment –III, Central Complex, BARC, Trombay, Mumbai -400 085. They are also required to submit "NO OBJECTION CERTIFICATE" at the time of written test and driving test failing which, they will not be allowed to appear for the tests.
- xi. Candidates are advised to submit the ONLINE application well in advance without waiting for the closing date.

10. COPIES OF CERTIFICATES:

<u>NOTE:</u> The candidates are required to produce printout of online application, admit card (to be downloaded from the website) & original certificates along with self-attested copies of certificates mentioned below ONLY at the time of <u>Written Test</u>. Candidates who report for the written test without any of the supporting documents will not be allowed to appear before the screening committee.

Candidates should submit along with their application, self attested SINGLE COPY of the certificates at the time of written test/driving test in support of :

- a. Educational qualification, experience (as applicable) and technical qualifications (supported by appropriate mark sheets indicating the subjects offered at the examinations)
- b. Date of Birth/Proof of age.
- c. SC/ST candidate's caste certificate should be issued by authorized authority in the prescribed format and the caste/community should have been included in the Presidential orders in relation to the concerned state. (Wherever applicable). (as per the format given in *Annexure-1*)
- d. OBC candidate's caste certificate should be issued by authorized authority in the prescribed format with non-creamy layer certificate and the caste/community should have been included in the Central list of Other Backward Caste. The crucial date for determining the OBC non-creamy layer certificate will be the *closing date of on-line application (28/03/2016)*. The OBC candidates should also enclose self declaration of non-creamy layer status in the *format as given in *Annexure-2**
- e. OBC for the purpose of AGE RELAXATION AND RESERVATION will mean "persons of OBC categories not belonging to the Creamy Layer" as defined in Government of India, Department of Personnel & Training OM No.36012/22/93-Estt.(SCT) dated 08.09.93, modified vide Government of India, Department of Personnel & Training OM No.36033/3/2004-Estt.(Res) dated 09.03.2004 and 14.10.2008, and latest modification vide Government of India, Department of Personnel & Training OM No.360331/1/2013-Estt.(Res) dated 27.05.2013 (as per the format given in Annexure-3*).
