- **(\$)** As no Destitute Widow candidate was available, the women candidate of the respective communal category is selected.
- (#) As per the para 7a of the notification, "In case marks are not specifically awarded for any batch of the Diploma in Prosthetics and Orthotics (Two year) course or its equivalent Diploma, then selection for all will be based on the marks scored by the applicants in SSLC and HSC / PUC examinations only".

As some of the batches of the Diploma in Prosthetics and Orthotics (Two year) have not been awarded marks for their technical diploma course, as such weightage has been calculated taking into account 30% weightage for HSC /PUC marks and 20% weightage to SSLC / 10th marks and Total weightage is calculated to 50%.

- a) The candidates have been provisionally selected based on the Weightage marks, verification of the mandated documents, and communal rotation etc. as per the existing orders of the Government of Tamil Nadu. In case where the marks obtained by two or more candidates are equal, the rank among them is decided based on the date of birth.
- b) Any claims preferred by the candidates should reach within 10 days from the date of issue of related provisional selection notification, appeals received after 10 days will not be entertained.
- c) The differently Abled candidates shall fulfill the norms as per G.O.(Ms).No.03, Health and Family Welfare (C2) Department dated 06.01.2016.
- d) The reservation to the posts have been done as per the 200 point roster issued in G.O.Ms.No.65, P&AR Dept. Dated 27.05.2009 and duly taking into consideration of all subsequent instructions of the Government in this regard.
- e) The selection is purely provisional subject to the outcome of the Writ Petitions relating to this recruitment, if any, pending on the files of the Hon'ble High Court, Madras/Madurai Bench of the Madras High Court.
- f) The provisionally selected candidates are advised to report immediately before the Director of Medical Education, Chennai-10. The appointment and posting orders will be issued by the Director of Medical Education, Chennai -10.
