#### **General Instruction-**

1. For the post of Pro V.C. the applicant must be a whole time professor of University.
2. All the information regarding Universities are available on their respective website.
3. The candidates for the post of Pro V.C. must not be above 62 years of age as on the date of publication of advertisement.
4. The application shall be submitted in a prescribed format, which can be downloaded from website of Raj Bhavan, Jharkhand, Ranchi having URL **[www.rajbhavanjharkhand.nic.in](http://www.rajbhavanjharkhand.nic.in)**
5. Recent self attested passport size photograph and signature of applicant shall be scanned at proper place.

6. The applicants need not submit any certificates in proof of his/her educational qualification.
7. All educational qualification must have been obtained from recognized Universities/Institution in India and abroad and if grades are awarded instead of marks, applicant should clearly indicate their numerical equivalent.
8. Incomplete application form is liable to be rejected.
9. Suppression of any material information or misrepresentation in the application shall automatically disqualify the candidate and further may attract prosecution.
10. Application received after due date and time shall not be considered.
