3.0 REMUNERATION: -

Consolidated Pay Band - Rs. 32,000-51,000 (4% annual increment) for <u>One year</u> probation period starting with consolidated monthly pay Rs. 32000/- (Rs. Thirty Two thousand) only.

After completion of one year of probation period from the date of appointment on consolidated pay, Regular Pay Scale PB-III, Rs. 15600-39100, GP-Rs. 5500 will be admissible subject to their conduct and performance remaining satisfactory and their achieving the minimum performance targets/ indicators decided and evaluated by the competent authority during the probation period.

- a. PHP (Physically Handicapped Person) Candidates shall get age relaxation by 10 years additionally in maximum age limit. They will have to produce necessary certificates in this respect.
- b. Land losers/ Land displaced persons due to land acquisition by erstwhile Bihar State Electricity Board, shall get relaxation in maximum age limit by 5 years additionally.
- c. For claiming relaxations in the Category of land losers/ land displaced persons, the Candidates have to produce certificate from concerned District Magistrate/ Dy. Commissioner, of the following effect to avail the benefit:-
 - That he is a land displaced person due to land acquisition by the erstwhile Bihar State Electricity Board.
 - ii. That his one acre or more land has been acquired for the construction of power plant or any other infrastructure of the Board.
 - iii. That no one from his family has benefited in preferential treatment in employment on the basis of land displaced person.
- d. For the purpose of calculation of maximum age of all Candidates who are domicile of other States than of Bihar, maximum age mentioned for UR Candidates shall be applicable.

5.0 **PROBATION PERIOD**:

The probation period shall be 3 years from the date of appointment.

If during probation period, the performance is not found satisfactory, the services shall be terminated.

6.0 RESERVATION:

- a. Reservation will be given in terms of reservation rules and policies as per Govt. of Bihar.
- b. The benefit of reservation is available only to the permanent domiciles of Bihar. The Candidate who claims for reservation benefit will have to submit the application along with the Caste and Creamy Layer Certificate issued by the Competent Authority of his/ her

- home district in the prescribed Performa of Govt. of Bihar issued not more than a year before. The Candidates belonging to SC/ST are required to submit only caste certificate.
- c. The Candidate who claims for reservation against relatives of Freedom Fighter as per Govt. of Bihar Resolution they have to submit the Certificate issued by the Competent Authority in the prescribed Performa of Govt. of Bihar.
- d. If a Candidate does not produce valid certificate of caste & creamy layer, Physically Handicapped, Land looser/ Land displaced persons or domicile etc., (as applicable), in original at the time of document's verification, his/ her claim for such reservation benefit will be forfeited and his/ her Candidature will be considered under UR category/ general candidate.

7.0 APPLICATION FEE:

 a. Application fee is Rs.1,500/- (Rupees One thousand five hundred) only for all categories except SC/ ST of Bihar domicile, for whom it will be Rs.375/- (Rupees Three hundred seventy five) only.

- d. Click to **On-line Application** for the post being applied for.
- e. Registration is mandatory for e-filling up the form. (Valid Email ID and a Mobile Number is necessary for registration).
- f. USER ID/ Registration ID will be generated after Registration.
- g. Use **USER ID and Password** (created by the candidates at the time of Registration) to Login and fill the Application form as in following manner:-

 - x. If claims reservation against relatives of Freedom Fighter as per Govt. of Bihar Resolution, the Certificate issued by the Competent Authority in the prescribed Performa of Govt. of Bihar
 - xi. Permanent Domicile of Bihar Certificate, if claim for reservation.

- i. Print a copy of finally submitted application form for future reference.

- a. Candidate already employed in Govt./ Semi Govt. organization/ Public sector must mentioned in application format. He/ She will have to submit NOC from his employer when shortlisted for Verification/Joining.
