Maharashtra State Electricity Transmission Company limited, a wholly owned corporate entity under the Maharashtra Government, was incorporated under the Companies Act, in June, 2005 after restructuring the erstwhile Maharashtra State Electricity Board to transmit electricity from its point of Generation to its point of Distribution. It owns and operates most of Maharashtra's Electric Power Transmission System. MSETCL operates a transmission network of 43730 Circuit KM of transmission lines and 633 EHV Substations with 110814 MVA transformation capacity. This infrastructure constitutes most of the inter regional as well as intra-regional electric power transmission system in the State. Today, MSETCL is the largest state transmission utility in the country. MSETCL has ambitious plan of its network expansion and invites applications from experienced, dynamic, talented and professional persons <u>for the post of General Manager (F&A)</u>

- 4. <u>Candidates who had submitted their applications in pursuance of earlier Advertisement</u> No. 06/2015 need not to apply again. However, they are required to submit documents i.e. experience certificates, salary slips / proofs etc. at the time of selection process.

5. PAY SCALES:

- i) The selected candidate will be drawing salary in the pay scale of ₹ 40790-1790-83750
- ii) In addition to basic pay, the selected candidate will entitle to DA, HRA, Medical Benefit, Leave Encashment, CPF and Gratuity etc. as per Company's rules.
- iii) In addition, hired vehicle, telephone reimbursement, etc. will be provided for official use as per company's rules.
- iv) The approximate monthly gross emoluments shall be ₹ 1,12,917/- (without office accommodation)
- v) Office accommodation can be provided as per Company's Rules, if available.

6. Upper Age Limit as on 31.05.2016- 48 years. Note:-

- The upper age limit for departmental candidates (only MSETCL Employees) is 57 years.

7. Methodology of Selection:

- i. Normally Competency Mapping Test will be conducted for selection process which will comprise of In-Basket Exercises, Group Discussion, Case Discussion, Presentation Skill and Personal Interview. However, which selection process is to be adopted will be at the absolute discretion of the Company and the decision of the Company in this regard shall be final.
- ii. All the candidates whose application received by <u>31.05.2016</u> shall be called for first four tools of Competency Mapping Test viz. In-Basket Exercise, Group Discussion, Case Discussion and Presentation Skill without verifying their eligibility i.e. age, qualification, experience etc.
- iii. The candidates will be shortlisted for Personal Interview in the prescribed ratio taking into consideration their performance in the In-Basket Exercises, Group Discussion, Case Discussion and Presentation Skill as well as verification of their eligibility i.e. qualification, post qualification experience, age, job responsibilities, etc as mentioned in the advertisement.
- iv. Taking into consideration, overall performance reflected in all five tools of Competency Mapping Test viz; In-Basket Exercises, Group Discussion, Case Discussion, Presentation Skill & Personal Interview the final select list shall be prepared.
- v. The list of finally selected candidates will also be displayed on the website.
