- (a) Essential: õ10+2 with Science subject or equivalent from a recognized board with one year Diploma in Medical Laboratory Technology (DMLT) or relevant subject from govt. recognized Organizations/Institutes/Medical Colleges and one year experience in recognized Institute Or 10+2 with Science subject with two years Diploma in Medical Laboratory Technology (DMLT) or relevant subject.
- **Desirable:** PG diploma in computer applications/ degree in computer science and additional laboratory/research field experience from reputed /govt. institute.
- (2) <u>Stenographer- 01</u> (Unreserved) (Pay Band-1 Rs.5,200-20,200 plus grade pay Rs.2400/-) in VI CPC pre-revised scale.
- (a) <u>Essential</u>:-12th Standard Pass from a recognized board/ University. (2) Should have a certificate of English Stenography from the recognized Board of Typewriting & Shorthand or equivalent with 80 words per minute speed in English Shorthand.
- (b) <u>Desirable</u> Knowledge of (a) handling day-to-day duties of a stenographer and making correspondences independently (b) knowledge of computer applications (c) Speed of 40 words per minute in English Typewriting and knowledge of Hindi typing and stenography.
- (c) Skill test in Stenography:

Candidates who obtain the qualifying marks in the Written Examination as may be prescribed by the Institute will only be called for the Skill Test of English Stenography. Institute shall prescribe qualifying marks of the Written Examination. THE SKILL TEST WILL BE OF QUALIFYING NATURE and merit will be prepared on the basis of marks scored in written test, of those, who will qualify in skill test.

The candidates will have to appear for the stenography test. The candidates will be given one dictation for 10 minutes in English. The matter will have to be transcribed on computer only. The transcription time will be 50 minutes (for English).

Candidates are advised that skill test in English Stenography is mandatory and, therefore, those without knowledge of English stenography should avoid applying for the examination.

Terms & Conditions:-

Age limit: Not exceeding 25 years for Stenographer & 30 years for Technician C.
