#### SELECTION PROCESS:

The selection method will comprise – Written Test & / or Personal Interview followed by Medical Examination as per post's category. The selection process would judge different facets of knowledge, skills, experience, expertise, aptitude and physical fitness. The candidates will be shortlisted for interview, based on their eligibility / experience in the relevant field. If sufficient candidates are not available for advertised post, then candidates with lesser service length / higher age / lesser experience may be considered for short-listing in the lower Pay Scale and Designation in NMRCL. Only SC/ST candidates are eligible for reimbursement of fare of 'to & fro' at the time of interview, maximum @ fare of sleeper class or by ordinary bus fare for the shortest route between his/her residential place to Nagpur, after production of valid tickets.

MEDICAL EXAMINATION:

The selected candidate will have to undergo medical fitness examination in NMRCL's nominated hospital as per the prescribed medical category. The details of medical standard can be seen on NMRCL Website (Link—Career).

2. Names of shortlisted candidates will be informed through E-mail provided in the application. The shortlisted candidates will have to appear for Written Test / Personal Interview on the scheduled dates and time with all original documents / testimonials and experience certificates. The interview will be held at Metro House, 28/2, Anand Nagar, C K Naidu Rd, Civil Lines, Nagpur - 440001. No separate communications by post will be sent to the candidates individually. The candidates are required to go through the instructions for Written Test /Personal Interview sent along with E-mail and appear for the said test accordingly along with original copies of testimonials.
